- 4. This agreement may be terminated by VMDL or Client without liability or cause be providing thirty (30) days written notice to the other party. In the event of termination and VMDL is not at fault, Client shall reimburse VMDL for all out-of-pocket expenses and non-cancelable obligations incurred.
- 5. This agreement shall be deemed to have been entered into under the laws of the State of Missouri and the rights and obligations of the parties hereunder shall be governed according to the laws of said state.
- 6. No member, individually or collectively, or office of the Board of Curators of the University of Missouri incurs or assumes any individual or personal liability by the executed of this agreement or by reason of the default of VMDL in the performance of any of the terms hereof. All such liability of members or officers of the Board of Curators of the University of Missouri, as such, is hereby release by Client as a condition of and in consideration for the executed of this agreement.
- 7. This agreement sets forth the entire understandings of the parties and supersedes any and all prior agreements, arrangements and understandings relating to the subject matter hereof.
- 8. By leaving my animal(s) at the Veterinary Medical Diagnostic Laboratory, I agree to pay the published animal disposal fee
- 9. Clients that are not residents of the State of Missouri agree to pay VMDL an initial deposit of \$190.00 at the time of signing. VMDL shall provide Client with an invoice upon completion of diagnostic accession work. Client shall submit full payment to the VMDL within thirty (30) days of invoice date. Failure to submit payment will result in the suspension of testing and future services being provided.
